Senator Bob Casey: Family Planning Legislative Record

- Consistently supports funding for Title X, the national family planning program to provide contraceptive services and other health care to low-income women.
- Supports access to Plan B (the morning after pill) as a form of contraception.
- Voted against the Fischer Amendment #630 to S.Con.Res. 8, the Fiscal Year 2014 Budget Resolution, which favored allowing employers and insurance companies to deny coverage for any essential health service they object to on the basis of personal religious beliefs or moral convictions.
- Voted in favor of the Shaheen Amendment #438 to S.Con.Res. 8, the Fiscal Year 2014 Budget Resolution, in support of protecting women's access to health care, including primary and preventative health care, family planning and birth control, and employer-sponsored contraceptive coverage.
- Voted against H. Con. Res. 36, which would have prohibited federal funds from going to Planned Parenthood under the Full-Year Continuing Appropriations Act, 2011.
- Voted against H.R. 1, the Full-Year Continuing Appropriations Act, 2011, which would have prohibited federal funds from going to Planned Parenthood and eliminated all funding for Title X.
- Voted in favor of H.R. 3590, the Patient Protection and Affordable Care Act, which included funding for community health centers and prohibited insurers from discriminating by gender.
- Voted for the Mikulski Amendment #2791 to the Patient Protection and Affordable Care Act to ensure coverage of preventive services for women.
- Voted against the Vitter Amendment #601 to H.R. 1105, the FY 2009 Omnibus Appropriations Act, to prohibit federal funds from going to Planned Parenthood.
- Voted against the Martinez Amendment #65 to H.R. 2, the Children's Health Insurance Program Reauthorization Act of 2009, which would have reinstated and codified the Mexico City Policy.
- Voted against the Brownback Amendment #2708 to H.R. 2764, the Department of State, Foreign Operations, and Related Programs Appropriations Act of 2008, which would have struck the provision that permits contraceptives to be provided to non-governmental organizations in developing countries who provide family planning and reproductive health counseling using their own private funds.
- Voted against the Vitter Amendment #3330 to H.R. 3043, the Departments of Labor, Health and Human Services, and Education, and Related Agencies Appropriations Act of 2008, to prohibit federal funds from going to organizations that perform abortions.

- Voted for the Boxer Amendment #2719 to H.R. 2764, the Department of State, Foreign Operations, and Related Programs Appropriations Act of 2008, to overturn the Mexico City Policy.
- Cosponsored S. 2347, the Prevention Through Affordable Access Act, in 2007 to restore availability of affordable birth control to low-income women and college students.
- Cosponsored S. 1075, the Unintended Pregnancy Reduction Act of 2007, to provide family planning services under Medicaid to predominately poor women who do not otherwise qualify for Medicaid.
