Hill Community Development Corporation	This project will provide funding for the New Granada Square redevelopment project in Pittsburgh's historic Hill District. City of Pittsburgh	This project will rehabilitate the House of Manna, a human services institution originally built by community activists and faith leaders that has since fallen into disrepair.
